

# Personal Social Health & Economic (PSHE) Education and Relationships and Sex Education (RSE)



Document Date: March 2025 Review Date: March 2026 This policy is based on the Jigsaw policy guidance but has been tailored to align with the specific needs and values of our setting.

# Context

All schools must provide a curriculum that is broadly based, balanced and meets the needs of all pupils. Under section 78 of the Education Act 2002 and the Academies Act 2010, a PSHE curriculum must:

- Promote the spiritual, moral, cultural, mental and physical development of pupils at the school and of society, and
- Prepare pupils at the school for the opportunities, responsibilities and experiences of later life.

This policy meets the requirements that schools publish a Relationships and Sex Education policy and does this within the wider context of Personal, Social and Health Education.

# Legal Requirements

From September 2020, all primary schools in England must teach relationships education and health education (as stated in The Children and Social Work Act 2017). These subjects cover:

- Relationships Education teaching children how to build positive and safe relationships with family, friends, and others online.
- Health Education covering physical health and mental well-being, helping children make good decisions, recognise issues, and seek help when needed.

Sex education is not a compulsory part of the primary curriculum, but:

- Relationships and health education includes learning about puberty.
- Science lessons include topics on body parts, human growth, and reproduction in some plants and animals.

The Department for Education has issued Statutory Guidance (2019) requiring primary schools to have a written policy on relationships education, which includes:

- How relationships education is taught.
- Any additional sex education beyond the science curriculum.
- Coverage of health education to support best practice.

# PSHE

At Cawston Grange Primary School, we teach Personal, Social, Health Education as a whole-school approach to underpin children's development as people and because we believe that this also supports their learning capacity.

The Jigsaw Programme offers us a comprehensive, carefully thought-through Scheme of Work which brings consistency and progression to our children's learning in this vital curriculum area. The overview of the programme can be seen on the school website.

This also supports the "Personal Development" and "Behaviour and Attitude" aspects evaluated under the Ofsted Inspection Framework, as well as significantly contributing to the school's Safeguarding and Equality Duties, the Government's British Values agenda and the SMSC (Spiritual, Moral, Social, Cultural) development opportunities provided for our children.

# **Statutory Relationships and Health Education**

"The Relationships Education, Relationships and Sex Education and Health Education (England) Regulations 2019, made under sections 34 and 35 of the Children and Social Work Act 2017, make Relationships Education compulsory for all pupils receiving primary education...They also make Health Education compulsory in all schools except independent schools. Personal, Social, Health and Economic Education (PSHE) continues to be compulsory in independent schools." DfE Guidance p.8

At Cawston Grange Primary School we value PSHE as one way to support children's development as human beings, to enable them to understand and respect who they are, to empower them with a voice and to equip them for life and learning.

We include the statutory Relationships and Health Education within our whole-school PSHE Programme.

To ensure progression and a spiral curriculum, we use Jigsaw, the mindful approach to PSHE, as our chosen teaching and learning programme and tailor it to children's needs. The mapping document: Jigsaw 3-11 and statutory Relationships and Health Education shows exactly how Jigsaw and therefore our school, meets the statutory Relationships and Health Education requirements. The link to the Jigsaw 3-11 and statutory Relationships and Health Education can be found below.

This programme's complimentary update policy ensures we are always using the most up to date teaching materials and that our teachers are well-supported.

Our PSHE policy is informed by existing DfE guidance:

- Keeping Children Safe in Education (statutory guidance)
- Respectful School Communities: Self Review and Signposting Tool
- Behaviour and Discipline in Schools (advice for schools, including advice for appropriate behaviour between pupils)
- Equality Act 2010 and schools
- SEND code of practice: 0 to 25 years (statutory guidance)
- Alternative Provision (statutory guidance)
- Mental Health and Behaviour in Schools (advice for schools)
- Social, emotional and mental wellbeing in primary and secondary education. (NICE guidance)
- Promoting and supporting mental health and wellbeing in schools and colleges (guidance for schools and colleges)
- Preventing and Tackling Bullying (advice for schools, including advice on cyberbullying)
- The Equality and Human Rights Commission Advice and Guidance (provides advice on avoiding discrimination in a variety of educational contexts)
- Promoting Fundamental British Values as part of SMSC in schools (guidance for maintained schools on promoting basic important British values as part of pupils' spiritual, moral, social and cultural (SMSC)
- SMSC requirements for independent schools (guidance for independent schools on how they should support pupils' spiritual, moral, social and cultural development).

The Jigsaw Programme is aligned to the PSHE Association Programmes of Study for PSHE.

### **Roles and Responsibilities**

A successful PSHE programme involves the whole school community:

Governors: Approve and support the RSHE policy.

Head Teacher: Oversees the delivery of RSHE, ensuring staff have the necessary training and resources.

Subject Leader: Keeps up to date with RSHE developments, supports staff, liaises with parents, and ensures lessons meet school values and legal requirements.

Teachers and Staff: Deliver the curriculum, model positive attitudes, and support pupils' learning and well-being.

Pupils: Engage in RSHE lessons with respect and openness.

Parents and Carers: Play a key role in their child's RSHE education. We encourage parents to attend RSHE workshops to:

- Understand what is being taught.
- Review resources.
- Learn how to support learning at home.
- Know their rights regarding RSHE, including the option to withdraw their child from sex education (but not relationships or health education).

# How PSHE is taught

To ensure a safe and effective learning environment, we:

- Establish ground rules for respect and confidentiality.
- Use stories, role-play, and discussions to create distance from personal experiences.
- Use clear and inclusive language.
- Adapt lessons to meet all pupils' needs.
- Provide opportunities for reflection and discussion.
- Answer pupil questions in an age-appropriate and sensitive manner.

### What do we teach when and who teaches it?

### Whole-school approach

Jigsaw covers all areas of PSHE for the primary phase including statutory Relationships and Health Education. The table below gives the learning theme of each of the six Puzzles (units) and these are taught across the school; the learning deepens and broadens every year.

Term	Puzzle (Unit)	Content
Autumn 1:	Being Me in My World	Includes understanding my own identity and how I fit well in the class, school and global community. Jigsaw Charter established
Autumn 2:	Celebrating Difference	Includes anti-bullying (cyber and homophobic bullying included) and understanding

Spring 1:	Dreams and Goals	Includes goal-setting, aspirations, who do I want to become and what would I like to do for work and to contribute to society
Spring 2:	Healthy Me	Includes drugs and alcohol education, self-esteem and confidence as well as healthy lifestyle choices, sleep, nutrition, rest and exercise
Summer 1:	Relationships	Includes understanding friendship, family and other relationships, conflict resolution and communication skills, bereavement and loss
Summer 2:	Changing Me	Includes Relationships and Sex Education in the context of coping positively with change

At Cawston Grange Primary School we allocate 1 hour to PSHE each week in order to teach the PSHE knowledge and skills in a developmental and age-appropriate way.

These explicit lessons are reinforced and enhanced in many ways:

Assemblies, praise and reward system, our school values and through relationships child to child, adult to child and adult to adult across the school. We aim to 'live' what is learnt and apply it to everyday situations in the school community.

Class teachers deliver the weekly lessons to their own classes. Occasionally these lessons may be delegated to other staff members to teach.

### **Relationships Education**

# What does the DfE statutory guidance on Relationships Education expect children to know by the time they leave primary school?

Relationships Education in primary schools will cover 'Families and people who care for me', 'Caring friendships', 'Respectful relationships', 'Online relationships', and 'Being safe'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Relationships Puzzle (unit) in Jigsaw covers most of the statutory Relationships Education, some of the outcomes are also taught elsewhere in Jigsaw e.g. the Celebrating Difference Puzzle helps children appreciate that there are many types of family composition and that each is important to the children involved. This holistic approach ensures the learning is reinforced through the year and across the curriculum.

#### **Health Education**

# What does the DfE statutory guidance on Health Education expect children to know by the time they leave primary school?

Health Education in primary schools will cover 'Mental wellbeing', 'Internet safety and harms', Physical health and fitness', Healthy eating', 'Drugs, alcohol and tobacco', 'Health and prevention', 'Basic First Aid', 'Changing adolescent body'.

The expected outcomes for each of these elements can be found further on in this policy. The way the Jigsaw Programme covers these is explained in the mapping document: Jigsaw 3-11 and Statutory Relationships and Health Education.

It is important to explain that whilst the Healthy Me Puzzle (unit) in Jigsaw covers most of the statutory Health Education, some of the outcomes are taught elsewhere in Jigsaw e.g. emotional and mental health is nurtured every lesson through the Calm me time, social skills are grown every lesson through the Connect us activity and respect is enhanced through the use of the Jigsaw Charter.

Also, teaching children about puberty is now a statutory requirement which sits within the Health Education part of the DfE guidance within the 'Changing adolescent body' strand, and in Jigsaw this is taught as part of the Changing Me Puzzle (unit).

Again, the mapping document transparently shows how the Jigsaw whole-school approach spirals the learning and meets all statutory requirements and more.

# **Sex Education**

The DfE Guidance 2019 (p.23) recommends that all primary schools have a sex education programme tailored to the age and the physical and emotional maturity of the pupils.

However, 'Sex Education is not compulsory in primary schools'. (p. 23)

Schools are to determine the content of sex education at primary school. Sex education 'should ensure that both boys and girls are prepared for the changes that adolescence brings and – drawing on knowledge of the human life cycle set out in the national curriculum for science - how a baby is conceived and born'.

At Cawston Grange Primary School, we define sex education as the process of developing children's understanding of human reproduction. It is essential that children receive accurate and reliable information about this topic before leaving primary school. This ensures they are well-prepared for the next phase of their education, equipped with knowledge that aligns with their peers, and confident in their understanding as they navigate their growth and development.

In today's world, children are increasingly exposed to representations of sex through social culture, media, and unregulated online content. Such exposure can often lead to confusion or, in some cases, dangerous misconceptions. Providing children with factual, age-appropriate information about human reproduction is not just beneficial—it is crucial. By empowering them with this knowledge, we help ensure their safety and enable them to make informed choices as they grow and face new challenges in life.

We intend to teach the children about human reproduction through our PSHE unit called 'Changing Me.' The delivery of the RSE curriculum will be through videos, diagrams and discussions.

# Parents' right to request their child be excused from Sex Education

A parent or carer cannot legally withdraw their child from any aspect of the statutory relationships education or health education. At Cawston Grange Primary School, puberty is taught as a statutory requirement of Health Education and covered by our Jigsaw PSHE Programme in the 'Changing Me' Puzzle (unit). A parent or carer does have the right to withdraw their child from sex education unless what is being taught is part of the science national curriculum. Following a consultation, the following content is deemed to be sex education:

- Year 6, Lesson 3 (Conception) understanding the place of sexual intercourse in a relationship and how it can lead to conception
- Year 6, Lesson 4 (Conception, birth) the story of pregnancy and birth

Before granting a request, the headteacher will discuss the request with parents or carers. The request for withdrawal should be put in writing and will be put onto the child's school record. The school will inform parents of this right by sending out a letter to the parents in the half term before the Changing Me puzzle is taught. Parents have the right to view any materials that the children will be looking at in these lessons.

The school will inform parents of this right to withdraw by email each year. The PSHE lead will also contact parents and carers to inform them, by email, the content of the lessons which will be taught across the school through the Changing Me unit in the summer term. This ensures that parents and carers can support their children with the content of the lesson, either by preparing them for it, or by being well informed and ready to answer questions following on from the lesson.

# Safeguarding

PSHE includes sensitive topics. It is, therefore, possible that discussions will prompt safeguarding disclosures. Reference should be made to safeguarding policies and procedures to deal with these appropriately. The subject leader/teacher should discuss with the designated safeguarding lead (DSL) any potentially sensitive topics. Appropriate steps must be taken to provide additional support for children if required. Staff should consider the timing of lessons to ensure that children have the opportunity to report any concerns they may have either that day or the following day.

### **Monitoring and Review**

The Curriculum Committee of the governing body monitors this policy on an annual basis. This committee reports its findings and recommendations to the full governing body, as necessary, if the policy needs modification. The Curriculum Committee gives serious consideration to any comments from parents about the PSHE (RSHE) programme, and makes a record of all such comments.

# Equality

### This policy will inform the school's Equalities Plan.

The DfE Guidance 2019 (p. 15) states, "Schools should ensure that the needs of all pupils are appropriately met, and that all pupils understand the importance of equality and respect. Schools must ensure they comply with the relevant provisions of the Equality Act 2010 under which sexual orientation and gender reassignment are amongst the protected characteristics.

At the point at which schools consider it appropriate to teach their pupils about LGBT (Lesbian, Gay, Bisexual, Transgender), they should ensure this content is fully integrated into their programmes of study for this area of the curriculum rather than delivered as a stand-alone unit or lesson. Schools are free to determine how they do this, and we expect all pupils to have been taught LGBT content at a timely point as part of this area of the curriculum".

Under the Equality Act 2010, the school is under a legal duty to eliminate discrimination, advance equality of opportunity and foster good relationships between those with protected characteristics and those without. The protected characteristics are:

- Age.
- Marriage and Civil partnership.
- Disability.
- Race.
- Religion and belief.
- Sexual orientation.
- Sex.
- Pregnancy and maternity.
- Gender reassignment.

In addition, the school must consider the needs of those with Special Educational Needs and Disabilities (SEND). The PSHE & RSHE curriculum meets the needs of all children and lessons include content that will tackle discrimination and foster good relationships.

At Cawston Grange Primary School we promote respect for all and value every individual child. We also respect the right of our children, their families and our staff, to hold beliefs, religious or otherwise, and understand that sometimes these may be in tension with our approach to some aspects of Relationships, Health and Sex Education.

#### Relationships Education in Primary schools (Appendix) – DfE Guidance 2019

The focus in primary school should be on teaching the fundamental building blocks and characteristics of positive relationships, with particular reference to friendships, family relationships, and relationships with other children and with adults. The references R3/H5 etc can be cross-referenced on the Jigsaw mapping documents and Puzzle Maps to show which lessons throughout Jigsaw contribute to which statutory outcomes. All statutory outcomes are covered in the Jigsaw 3-11 Programme.

### Physical health and mental well-being education in Primary schools – DfE Guidance

The focus in primary school should be on teaching the characteristics of good physical health and mental wellbeing. Teachers should be clear that mental well-being is a normal part of daily life, in the same way as physical health.

By the end of primary school:
